Each pet delivered must be accompanied with a certificate of veterinary inspection as well as complete vaccination and deworming records.

1. Registration paperwork must be sent within a couple of weeks.
2. If within 2 days of receipt of their pet the customer has it examined by a licensed veterinarian, who finds it to be unfit for purchase due to
3. Life threatening genetic defect, example heart murmur, we will provide a replacement pet of equivalent value to the customer.
4. If within 1 year from the date of purchase the pet is found and certified by a licensed veterinarian to have congenital or hereditary disorders, which adversely affect the health of the animal, seller must provide a replacement of equivalent value (providing that the customer informed seller of the situation within 2 business days of the diagnosis). We hope that you will enjoy your new pet for years to come. We have taken steps to ensure that your new pet is healthy.

1. The purchaser must have the puppy examined by a licensed veterinarian within two (2) business days of the purchase. Seller has had puppy examined by a licensed Mo. DVM and certificate sent with puppy of health. The puppy will be free of Parvo-virus & Distemper and vaccinated accordingly up to date of placement.

2. If the examination indicates that at the time of sale, such animal was unfit for purchase due to life altering genetic defect, you may return the pet to the breeder for an exchange of equivalent value.

3. If within one (1) year from the date of purchase from Breeder, a dog is found and certified by a licensed veterinarian to have congenital or hereditary disorders which adversely affect the health of the animal, and if Breeder is notified within two (2) business days of the veterinarian's determination, the breeder will provide a replacement puppy of equivalent value. However, the Breeder will not be responsible for veterinarian fees, costs or shipping cost.

4. There is no guarantee or warranty that the purchaser will be able to show or breed the pet. If puppy is purchased with full AKC reg. the dog must be altered if you are unable to keep or be sent back to seller.

5. In the event of any litigation in connection with this Guarantee, Breeder will be paid reasonable attorney fees by the purchaser. Venue and jurisdiction for litigation arising out of or related to this contract shall lie exclusively in Breeders County and State. Greene County, Springfield, Mo.

Registration papers for all registered puppies will be sent by regular mail. If the papers are lost, the purchaser is responsible for the cost of obtaining new papers. Online reg. is an option for lost papers and we are more than happy to do this if necessary.

Limitations of Guarantee:

This guarantee is non-transferable. The dog must be in good physical condition. No replacement will be given if the female has been bred. No replacement will be given if breeds that are known to be prone to hip dysplasia are over weight or over exercised. No replacement if the registration application form has expired. You must follow the Breeder recommended nutritional program, including recommended dog food and vitamin supplement listed on your Puppy Instruction Form included in your packet. All dogs must not be over exercised during their growth period. Over exercising is as follows: running with the dog or jumping the dog. All the above mentioned conditions must be met or all guarantees above mentioned will be void. All laboratory verification must be done by a licensed veterinarian. The owner is responsible for transportation costs to and from the Seller. Seller is not responsible for any and all veterinarian expenses accumulated on returned or replaced dog or puppy. Seller sells pets for companion purposes only.

I, the purchaser of a puppy from said Breeder hereby acknowledge that I have received a copy of this document as well as described herein pertaining to my pet's health inspection signed by a licensed veterinarian. Further, I accept the terms and conditions of the guarantee for congenital or hereditary disorders printed in this document, and I waive and relinquish any and all other rights that I might otherwise have in the event of such occurrence. The purchaser acknowledges that he or she

has read, understands and agrees to the terms of this document.
